

Welcome to the 2024-2025 Sailing Club season, our 41st year as a Sailing Club. We welcome back our veteran members and extend a warm welcome to our new members and those considering membership.

We have planned some very exciting trips and hope you will be part of the fun. The Club is run solely by members. Any member may present a trip to the Board, and may also help run it. If there is a trip you would like to propose (and enjoy a substantial discount if you help run it), please reach out to any Board member.

The season will start with a return to a live and in person On-land Training session on May 4th. As before, it will cover such topics as Rules of the Road, Communication, and Personal and Boat Safety. This will be followed up by our highly desirable On-Water Training two weeks later. This is a perfect opportunity to brush up on your sailing skills and learn new ones.

In June, a three day sail from Rock Hall will visit Crab Alley Creek on the way to St. Michaels. This is solstice weekend with the longest day of the year included. Mia McCroskey has planned a pleasure filled weekend with a night at St. Michaels Harbour Inn Marina.

Mid-August will find us again on the Chesapeake, sailing from Rock Hall to Worton Creek via Bodkin Creek, with our classic raft-up party the first night. 2024 Information Package

MEMBERSHIP

Participation is open to anyone interested in joining. Sailing experience is not necessary, but sailing (cruising) is the main activity of our Club. Annual membership fees are currently \$40 for an individual or \$50 for a household - all individuals residing at the same address. This fee helps to defray some of the Club's non-trip operating costs. Please forward any changes in address to the Membership Secretary (membership@thesailingclub.org).

NOTE: You must be a Sailing Club member to participate in any Club event. A membership form is available from the Membership Secretary or any Trip Leader. It is also available on the Club website: www.TheSailingClub.org, as well as at the back of this package.

TRIP SIGN-UP PROCEDURES

After you decide which trip(s) you want to go on, complete the two-page Reservation/Release Form for *each person* on each of those trips. Forward these forms, with a deposit check for each person on the form, payable to *The Sailing Club*, *Inc.*, to the person indicated on the reservation form. Reservation Forms not accompanied by payment will not be accepted.

Regardless of whether you receive this package at the Annual Meeting or other means, Trip Leaders will accept reservation forms at any time on or after April 1, 2024 but will not process them until **APRIL 15, 2024**, except for OWT, which is on a first-come, first-served basis. On that date, all reservations received to that point will be recorded in a random draw. All reservations received after that date will be recorded in the order received. *Membership in the Sailing Club does not guarantee you a spot on a trip*.

New members are encouraged to try a weekend trip before signing up for any week-long (or longer) trips.

A confirmation notice will be sent to you indicating your status on the trip. Your status will be one of the following:

Confirmed: You are a confirmed participant. When boat and crew assignments have been made, you will be sent a copy of the crew list.

Wait-listed until additional crew and/or skippers sign up: There is still space on the trip, but additional crew and/or skippers are needed before further boat and crew assignments can be made.

Wait-listed on a full trip: As of the day your reservation form was received, the trip was full. The Trip Leader will keep you advised of any changes in this status. Reservation checks will not be deposited until you are confirmed on the trip.

If you know in advance that a trip is full and you want to be placed on the wait-list, you must still send in a reservation form and a deposit check.

Typically, a boat will sail with no more than one empty space aboard. Vacancies will be filled from the trip wait-list. Deposit checks will be returned, usually *after* the trip has been completed, to anyone wait-listed who does not get on a trip.

Qualified skippers who want to reserve an entire boat must first contact the Trip Leader to confirm boat availability. A reservation form and a check covering <u>all</u> spaces on the boat must be sent to the Trip Leader.

TRIP PRICING

The trip price includes charter fees for the boats and occasionally pre-determined miscellaneous trip-related expenses such as slip fees. Food, fuel, traveling expenses, and other incidentals are handled separately by each boat's crew, and are NOT included in the quoted trip price, except as described in the write-ups.

The Club covers its members for the damages that may occur on the trip. Nonetheless, this does not relieve the skipper AND crew from equally sharing the responsibility for providing for a safe and enjoyable trip for all involved.

The price for children is pro-rated based on sleeping accommodations. If a child shares a bunk with his/her parents or if two children share a single bunk, their cost is half the trip price. A child using one bunk exclusively travels at full trip price.

The Sailing Club, Inc. depends solely on the voluntary efforts of Trip Leaders, Assistant Trip Leaders and Club-qualified skippers to plan, organize and lead the various cruising activities the Club engages in.

In recognition of the large amount of effort and responsibility these individuals undertake, the following trip price discounting applies: Trip Leaders and Skippers shall each receive a 50% discount; Assistant Trip Leaders shall receive a 25% discount; before any non-discounted expenses, such as moorings or transportation. No individual receives more than one discount.

FINAL PAYMENT

A payment schedule is located at the end of each trip write-up with final payment due dates indicated on both the trip reservation form and the confirmation notice. Late payments are subject to a \$10 late charge.

New reservations made after the final payment date must include FULL payment. Late charges <u>do not apply</u> in this situation.

CANCELLATIONS AND REFUNDS

For most trips, full refunds will be given for cancellations made **30 days or more** (or as stated in the trip write-up) before the trip departure date. Cancellations after that date are **not** refundable if no replacement is found, regardless of reason, even medical. Otherwise a \$25 fee will apply, regardless of reason or replacement.

In the event anyone cancels **less than 30 days** (or as stated in the write-up) before the trip departure date, and no replacement is available, he or she will also be required to pay any additional fees and charges that cannot be canceled prior to the trip, in addition to forfeiting all trip fees paid to date.

For trips that require more advanced planning, stricter refund policies may be implemented. Participants are always advised to read all trip documentation carefully.

NOTE: Individuals will not be permitted to select a replacement unless the wait-list is empty.

Any refunds due will typically be held until <u>after</u> the trip has been completed unless the Treasurer and the Trip Leader both agree to an alternate arrangement.

TRAVEL INSURANCE

The Sailing Club recognizes that some trips represent a significant investment for its members. The Club also feels that this long-standing cancellation policy is more than fair to its members. However, it is possible for members to individually take out travel insurance for a particular trip. There are several publicly available policies that can provide coverage for medical expenses, trip cancellation/interruption, baggage damage, and more. Members should make their own decisions regarding insurance that would provide coverage appropriate to their needs, and that they feel best protects them in their individual situations. Two useful resources for comparing plans are www.insuremytrip.com and www.insuremytrip.com and www.squaremouth.com. An inexpensive provider is World Nomads (www.worldnomads.com).

BOAT AND CREW ASSIGNMENTS

Several weeks prior to the trip, the Trip Leader meets with the designated skippers to assign boats and crew. Primary importance is given to ensuring that each boat has sufficient experience among the crew. Once those crewmembers have been assigned, the rest of the crewmembers are allocated. Safety is, has been, and always will be, our number one consideration.

If you or anyone in your party has a medical or physical condition (i.e., allergies, restricted mobility, motion discomfort, non-swimmer, etc.) that might affect your safety or anyone else's, you may want to advise your skipper, or a fellow crew member. This may be done privately, and should be done before boarding the boat, if not prior to the pre-trip meeting. Some suggestions can then be offered to safeguard your comfort and well being. Please note that sailing conditions are dynamic, that your safety, and that of your crewmates, depends on your good physical health and agility.

The boats we charter are all different in regard to model, size, age, overall layout, and interior accommodations. *Furthermore, boats are randomly assigned*. Crew assignments will be made with as much consideration given to personal preferences as possible, including smokers/non-smokers, and sleeping arrangements (i.e., couples/singles, distribution of males/females).

Minor children may be accommodated on any trip. Children will only be assigned to a boat with the complete agreement of the skipper and the entire crew. Children's reservations will be taken in order of receipt and will maintain their priority as boats are filled. Children under the age of 12 are required to wear a life jacket at all times, except when below decks.

PRE-TRIP MEETING

An informational meeting for all trip participants is held approximately two weeks prior to each trip. The Trip Leader will forward information and location for the meeting. At the pre-trip meeting, the Trip Leader will summarize the proposed trip itinerary and answer any questions you may have concerning the trip. Individual crews have the opportunity to meet their skipper and crewmates in order to plan meals, decide berth assignments, and organize travel arrangements. All crewmembers are encouraged to attend.

ADDITIONAL TRIP INFORMATION AND DETAILS

On the first night of each trip crews usually arrive at the marina, stow their gear, have dinner at a local restaurant, and sleep aboard the boats. The skippers and charter agent will conclude the boat checkout the following morning, if not completed the previous day. Then the crews will be thoroughly briefed on boat operations and safety. Finally, the trip is under way!

The Trip Leaders plan an itinerary for the trip which, for weekend trips, typically includes anchoring out one night and the opportunity to explore and dine ashore another. Longer trips offer more opportunities for both. Breakfast and lunches are normally eaten aboard. Individual boats may opt to establish their own daytime cruising plans according to the desires of the skipper and crew; however, all boats are expected to meet at the designated evening anchorage. Hourly radio checks confirm each boat's location and progress.

All trips provide many opportunities to brush up on sailing skills, relax, and socialize. On some trips, there are possibilities for sightseeing ashore, possibly go for a swim when at anchor or at a marina pool.

In general, all boats are equipped with stoves, ovens, ice box or refrigerator, a limited supply of hot and cold running water, showers and toilets, and basic kitchen utensils. Boats typically feature a galley area (kitchen), salon (living/dining room), heads (small bathrooms!) and forward and aft cabins. In addition to assigned food and beverage responsibilities, crewmembers should bring bedding and towels, unless provided by the charter company, and outdoor wear suited to the trip location and season. Always pack less, always casual and easy to wash clothing, and always pack in soft luggage.

No two boats, even of the same model, are identical. However, in general, onboard accommodations are simple and efficient, sometimes described as "camping on the water." It is also close quarter living at its best! The fresh breezes, blue waters, the thrill of adventure, and perhaps most importantly, the camaraderie of the group are the true incentives of our trips!

Remember...we sail rain or shine, so be prepared!

ON THE WATER TRAINING ROCK HALL, MD

May 18 – 19, 2024 Early board May 17

This two-day training experience is your opportunity to get back on the water and practice your boat handling and sailing skills. On the Water Training (OWT) gives new sailors experience steering the boat and performing each role during anchoring, reefing, rescuing, and sailing. Experienced sailors have the opportunity to take command through practice maneuvers, and brush up on less-used skills.

This year's OWT will include exercises in line handling and steering while leaving and approaching docks, slips, and moorings. We'll practice rafting and separating, as



well as anchoring techniques. We'll review effective communication -- both on board and over VHF -- and practice sailing skills, including sail trim, tacking, and jibing.



Tentative agenda:

Friday Early boarding around 4:00 p.m. if boats are available. Dinner in town.

Friday 9:00 p.m. – Post-supper discussion of the effects of wind, current, and prop walk while maneuvering.

Saturday 8:00 a.m. to 4:00 p.m. – Boat systems overview, communication, essential knots. Under power exercises. Under sail exercises. Lunch on the water. Dinner ashore.

Sunday 8:30 a.m. to 3:00 p.m. – Under sail – sail trim, man overboard, heave to. Anchoring and rafting drills. Lunch on the water.



Thursday, June 20


Early boarding in Rock Hall after about 4:00 p.m. Dinner ashore.

Friday, June 21 (33 nm)

We'll need an early departure from Rock Hall in order to sail to Crab Alley, located on the south side of Kent Island. As going through Kent Narrows is not allowed by the charter company, the sail will take us south from Rock Hall into the Bay, around Kent Point and up Eastern Bay. Crab Alley is protected from the southwest and north, and provides great anchoring for our raft-up and traditional Club appetizer dinner party.

Saturday, June 22 (10 nm)

Sail south to St. Michaels and find our reserved slips at the St. Michaels Harbour Inn Marina (https://www.harbourinn.com). Visit the Chesapeake Bay Maritime Museum (https://cbmm.org), the brewery, the winery, or just wander the town. Our slips include use of the swimming pool and pool towels, bicycles, and a shuttle services



into town (which is also very walkable). Dinner is ashore at any of St. Michaels' numerous restaurants. Reservations are recommended, and this will be discussed at the pre-trip meeting.



Sunday, June 23 (40 nm)

An early departure from St. Michaels will be needed for the long sail home, retracing the route via Eastern Bay and around Bloody Point Light to Rock Hall, where we need to fuel up and pump out, and be off the boats by 5:00 pm.


The Boats

The cost of this trip is \$575.00 per person (Skippers and Trip Leader - \$304.00, Asst. Trip Leader - \$440.00). The price includes charter fees, one night's slip fees, Provisioning, fuel, pump-out, any additional mooring fees, dinners ashore, and other incidentals are additional and will be handled by each boat's crew.

The deposit for this trip is \$100.00. Please make your check payable to *The Sailing Club, Inc.* and mail it, along with your completed two-page Reservation/Release Form, to Mia McCroskey at the address below. Reservations will be processed beginning April 15, 2024 with a random draw of those received by that date. All reservations received after that date are on a first come, first served basis. A final payment of \$475.00 is due on May 7, 2024. The Club's standard thirty-day cancellation policy applies for this event.

A pre-trip meeting will be held a couple of weeks before the trip, at a time and place to be announced. All crewmembers should make every effort to attend in order to meet your crewmates, plan your meals, and make travel plans.





ROCKLAND, MAINE EGGEMOGGIN REACH, WOODEN BOAT SCHOOL MT. DESERT ISLAND

September 15 – 21, 2024 Early Board September 14

The Sailing Club is returning to Maine. With more coastline than California, Maine is one of the best places in the country to explore by water. This is a seven day trip during which we'll sail the pristine waters of Penobscot Bay, Eggemoggin Reach, Southwest Harbor, Somes Sound, Frenchman Bay and Bar Harbor.

We'll sail past many of Maine's more than two hundred rocky islands and outcroppings that are set against a backdrop of surrounding and sometime sheer mountains, seeing picture postcard village after picture postcard village,

photo-worthy lighthouse after photo-worthy lighthouse, and possibly the occasional Tall Ship. We'll spend time trying to tell whether those are dolphins or seals swimming with the boats.

We will also visit the Wooden Boat School (https://www.thewoodenboatschool.com) in Brooklin, offering insights into the facilities that continue the proud Maine heritage of wood boat building and samples of their work. Traveling into Somes Sound and then on to Bar Harbor will offer a perspective of Acadia National Park (https://www.nps.gov/acad/index.htm) unique from that of a land tour. Of course there will be a number of opportunities to feast on "fresh from the waters" lobster at local restaurants or, perhaps, steamed on board after dropping a pail to a lobster harvester and negotiating a cash price.

THE ITINERARY

Saturday September 14. 2024 - All crews will need to arrive in Rockland in time to complete any provisioning prior to boarding the boats. After the skippers complete boat checkouts, we'll load provisions and gear and then proceed to one of the local restaurants for dinner ashore, perhaps overlooking the scenic harbor.

Sunday September 15, 2024 - Following a very early morning departure from Rockland Harbor, we'll turn north and east, sailing to the northern end of Eggemoggin Reach. As we pass picturesque villages, we'll turn southward, proceeding under the Deer Isle Bridge – sister bridge to the (in)famous Tacoma Narrows Bridge, *Galloping Gertie*, that collapsed in 1940 shortly after opening. Then it's on to the Wooden Boat School in Brooklin, completing a 32 nm leg. There we'll either pick up moorings or anchor and possibly raft up. To the extent daylight permits, crews can dinghy ashore and visit the Wooden Boat School. If rafted, crews will have the opportunity for an appetizer dinner and plenty of socializing.

Monday September 16, 2024 - Crews can get up early and dinghy ashore for another chance to visit the Wooden Boat School. Later in the morning we'll proceed 18 nm and plan to take slips or mooring at Dysart Great Harbor Marina in Southwest Harbor, perhaps taking advantage of the short distance to enjoy some open water sailing prior to proceeding to port.

Once at Dysart Great Harbor Marina in Southwest Harbor, crews can enjoy the use the marina's ample facilities, walk into town to visit the numerous shops, and enjoy any of the many restaurants noted for their seafood (particularly lobster) and barbecue.

Tuesday September 17, 2024 - We'll travel the 6 nm to and up Somes Sound in Acadia National Park, proceeding all the way up to Somesville Landing where crews can dinghy ashore. Other possible nearby stops for the night are John M Williams Boat Company and Henry R. Abel & Company Yacht Yard, which may have moorings or slips. Crews have the option to eat aboard, picnic ashore or eat at a nearby restaurant.

Wednesday September 18, 2024 - After breakfast and perhaps a morning of further exploration, we'll sail 16 nm up to Frenchman Bay and plan to take slips or moorings in Bar Harbor. Upon securing the vessel, crews can proceed to use the available facilities and explore, and eat ashore or on board.

Thursday September 19, 2024 - Following an early morning departure from Bar Harbor, it's 39 nm to Duck Harbor anchorage on Isle au Haut, where the boats can anchor and raft up. To the extent daylight permits, crews can dinghy ashore to explore this less visited part of Acadia National Park before dinner aboard.

Friday September 20, 2024 - Following perhaps an early morning breakfast and dinghy ride ashore to explore a little bit more, we'll sail 12 nm to moorings at J.O. Brown Company in North Haven. Enjoy beer, ice cream, and perhaps dinner, ashore at Calderwood Hall. You may also be interested in some special baked goods, sold across the street, for the next morning's breakfast.


Saturday September 21, 2024 - It's up again early for the 11 nm return to Rockland Harbor. After fueling up, pumping out, and refilling the water tanks, it's off the boats and on to wherever people intend to go next.

Getting There and Away

It is served by Cape Air, with several flights daily from Boston's Logan Airport (BOS). Portland International Jetport (PWM), with direct flights from Newark, is about a two-hour drive, if you can arrange a carpool or one-way car rental.

<u>CIRCUMNAVIGATING THE SOUTHERN CHESAPEAKE</u>

Last season, The Sailing Club explored "The Undiscovered Waters to the 'Middle of Nowhere," venturing into the Potomac River for a most successful sail. This year, we will again depart from Safe Harbor Zahnisers Marina in Solomons, Maryland, taking advantage of its location to sail a counterclockwise circumnavigation of the Lower Chesapeake. This is an eight-day trip, with four nights in slips alternating with four nights at anchor.

THE FLOAT PLAN

Saturday October 12 - Crews should plan on arriving at Safe Harbor Zahnisers Marina in the afternoon. After the skippers complete their checkouts of the boats, we'll load provisions and gear and then proceed to one of the local restaurants for dinner ashore, while perhaps enjoying the sunset reflected in the Patuxent River or Back Creek.

Sunday October 13 - We will begin our 42 nm sail with an early morning departure, proceeding out of Back Creek and into the Patuxent River, then into Chesapeake Bay. Once past Cedar Point, we'll turn south and continue past Point Lookout and across the mouth of the Potomac River. Our destination this evening is an anchorage in Mill Creek on the Great Wicomico River off Ingram Bay. The boats will raft up and crews will have the opportunity for a traditional appetizer dinner and plenty of socializing.

Monday October 14 - In the morning, we will head back out to the Bay and continue 21 nm south, crossing the mouth of the Rappahannock River before proceeding into the river to Safe Harbor Stingray Marina in Deltaville, Virginia. We will take slips so that crews can take advantage of the marina's amenities, including propane grills for cooking dinner.

Tuesday October 15 - Today's 32 nm journey begins with making our way back into the Rappahannock River and east past Stingray Point into the Bay. We'll again head south to an anchorage in the Severn River (not the Annapolis one) off Mobjack Bay where the boats will again anchor and raft up for the night.

Wednesday October 16 - Today's sail takes us across the bay about 29 nm to Cape Charles (https://capecharlesvirginiascape.com) at the south end of the Delmarva Peninsula. Slips have been reserved for two nights at the Cape Charles Town Dock, allowing time to explore this town that is on the National Register of Historic Places, due to having one of the largest concentrations of turn-of-the-century buildings on the East Coast.

Thursday October 17 - Today is a layover day to allow time to further explore Cape Charles, from its galleries and beach-y boutiques to the world's most Instagrammable bookshop. Cape Charles' walkable retail district is a delight to browse.

Friday October 18 - After making our way back into the Bay, a northward heading will take us to an anchorage in Pungoteague Creek, about 35 nm away. The boats will once again anchor and raft up for the night.


Saturday October 19 - Departing Pungoteague Creek we'll continue the northward part of the circumnavigation 29 nm to Somers Cove Marina at Crisfield, Maryland, where we will pick up slips, plug in and be able to take advantage of the amenities of the marina and surrounding area, including many restaurants.

Sunday October 20 - Early the next morning we will make our way 40 nm north and west, completing the circle to Safe Harbor Zahnisers Marina. Crews will pump out and fuel up before heading home, or wherever else you might want to go.

The Boats

We have chartered two sloops from Sail Solomons (https://sailsi.com) in Solomons, Maryland. Each offers comfort and ease of sailing. Ripple will have a crew of six, while Moxie will have a crew of five.
